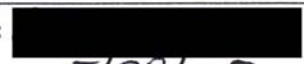

TO THE DEFENDANT: The above named plaintiff(s) asks judgment against you for \$ 5500.00 together with costs upon the following claim (Civil fines must include citation of the statute or ordinance violated):

On February 23, 2005, the plaintiff loaned the defendant \$6000.00 to help him purchase a new SUV. The defendant explicitly asked the plaintiff on that date if this was a loan, and I, the plaintiff, said it was. The defendant made the plaintiff swear to secrecy on the loan given that he believed some unnamed individuals may use it against him. There was no specific date made for full repayment of the loan but it was agreed by both parties that the loan without exception had to be repaid before the wedding of the plaintiff. The plaintiff was married on November 24, 2007.

The defendant repaid \$1000 to the plaintiff. The \$1000 check was originally made out in February 2007 and was delivered to the plaintiff in July 2007.

An extra claim of \$500 is attached to this case to cover travel costs for the plaintiff from CA to PA as if the defendant had paid on time, the plaintiff would otherwise not have needed to pay this money.
